**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
LIVINGSTON PERMITTING REFUNDING PAYMENTS OF UNBILLED THIRD AND
FOURTH QUARTER 2018 PROPERTY TAXES**

WHEREAS, under the prior tax law for federal returns, the state and local deduction better known as SALT was unlimited; and,

WHEREAS, the newly passed federal tax law takes away people's abilities to deduct much of what they pay in state and local taxes from their income or federal tax returns with deductions limited to \$10,000.00 and a combination of property taxes and other state and local taxes; and

WHEREAS, residents of Livingston made payments in December of 2017 toward unbilled third and fourth quarter 2018 property taxes; and

WHEREAS, Livingston residents are now seeking refunds of these unbilled third and fourth quarter property taxes; and

WHEREAS, as a matter of policy (on the basis that a third and fourth quarter is in excess of the tax or assessment levied, which is unknown at this stage) they should be entitled to a refund.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Livingston, County of Essex, State of New Jersey that the tax collector is permitted to refund payments of unbilled third and fourth quarter property taxes paid in December 2017 upon the written request of the taxpayer.

RESOLUTION AUTHORIZING A CONTRACT WITH BRAVE INDUSTRIAL PAINT, LLC

WHEREAS, the Township of Livingston ("Township") has a need for the Rehabilitation of the Chetwynd Water Storage Tank that cannot otherwise be performed by its regular employees; and

WHEREAS, on December 21, 2017, the Township of Livingston issued Bid No. 13R-2017 as a re-bid to solicit bids from contractors experienced in tank rehabilitations; and

WHEREAS, the bid was advertised on the Township of Livingston website and West Essex Tribune on December 21, 2017 and as a result eight (8) bid packages were requested; and

WHEREAS, on January 17, 2018, four (4) bids were received by the bid deadline and publicly read; and

WHEREAS, Brave Industrial Paint, LLC was identified as the lowest responsive and responsible bidder whose bid meets all of the requirements of the bid specifications, complies with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.S.A. 17:27 et seq., is responsive and responsible; and

WHEREAS, the Consulting Engineer and the Junior Utility Engineer have evaluated the proposal for qualifications, experience, and cost reasonableness, and recommend the award of a contract to Brave Industrial Paint, LLC; and

WHEREAS, the Acting Township Manager is recommending the award of a contract Brave Industrial Paint, LLC in an amount not to exceed \$725,000.00; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available in accounts C-06-55-015-007-01F, C-06-55-014-008-01A, C-06-55-016-003-004, C-06-55-017-003-006, C-06-55-017-003-007, C-06-55-014-008-01C, C-06-55-016-003-001 and C-06-55-015-007-01I.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Livingston, in the County of Essex, State of New Jersey, that it authorizes the Acting Township Manager to enter into a contract with Brave Industrial Paint, LLC in an amount not to exceed \$725,000.00.
