New Business

- Mr. Yu Liu,141 Madison Court, and Mr. Timothy Wu, 47 **Congressional Parkway**, remarked that the consensus from the neighbors was no parking on both sides of the street due to the confusion of which day of the week which side of the street was designated for parking. They inquired if parking at Northland could be expanded.
- Township Manager Lewis mentioned that bids for disc filters for the wastewater treatment plan were received, and he supports Township Engineer Jeanette Harduby's recommendation to award the contract to Allied Construction Group, Inc. He added that a Resolution is on tonight's August 8, 2022 Agenda for the Township Council's consideration.
- Township Manager Lewis stated that the ROID (Recreational Opportunities for Individuals with Disabilities)

 Grant is an annual application, and that Jennifer Walker is requesting a grant for approximately \$15,000 \$25,000 to carry out project ideas. He added that a Resolution is on tonight's August 8, 2022 Agenda for the Township Council's consideration.
- Township Manager Lewis mentioned that the Township's Affordable Housing Services and Rehabilitation Services contract is set to expire and he concurs with Planning Administrator Jackie Hollis's recommendation of the award of contract to **Community Grants**, **Planning & Housing**, **LLC** for a twelve month period.
